GAPFA MEMBERS DISCUSSED ISSUES OF MUTUAL INTEREST AT THE GAPFA CONGRESS AND AGM 2019

From 29th October to 31st October 2019, over 35 representatives from 12 GAPFA members took part of the GAPFA annual Technical Congress and General meeting in Mexico City, hosted by AMASCOTA.

The GAPFA Technical Congress participants were presented with an overview of pet food regulations in Mexico made by Dr Teresa Cervantes from SENASICA, including highlights about pet food penetration campaign in Mexico presented by Mrs Zerene Kahan Oblatt & Mr. Nicolás Torino (AMASCOTA – CONAFAB). In addition, the participants welcomed Mr Dewey Warner from Euromonitor, who provided insights about the new generation of pet owners transforming the industry. Finally, a speaker from SSAFE, Mr Quincy Lissaur, provided an overview of the SSAFE organisation, the current projects & initiatives and explored possibilities for collaboration.







GAPFA member associations presented their country/regional reports about their current and future activities and emerging issues.
